Dogs not required for further judging will be excused. **Judges will not wait for any dog holding up a class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged. **All dogs present must be held on leash** or confined to their crates except when being judged or when in the exercising pen. **No gasoline or diesel generators** are permitted within 100 feet of any tent in which this dog show is conducted
